ORDINANCE NO. 2025 - 14

AN ORDINANCE OF THE CITY COMMISSION OF DELAND, FLORIDA, CHANGING THE ZONING FROM VOLUSIA COUNTY'S R-4, URBAN SINGLE-FAMILY AND CITY OF DELAND'S R-1, SINGLE-FAMILY RESIDENTIAL TO CITY OF DELAND'S R-1B, SINGLE-FAMILY RESIDENTIAL ON PROPERTIES LOCATED AT 1101 SOUTH AMELIA AVENUE; MAKING FINDINGS OF CONSISTENCY WITH THE COMPREHENSIVE LAND USE PLAN FOR THE CITY OF DELAND; DIRECTING CHANGE IN THE COMPREHENSIVE ZONING MAP; CONDITIONING FINAL DEVELOPMENT ORDERS ON A DETERMINATION OF CAPACITY; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE
